TERMS AND CONDITIONS
WELCOME OFFER PROGRAM
INVESTMENT ACCOUNT

INTRODUCTION

Trading.com Markets UK Limited, trading under the name Trading.com, is a UK Investment Firm (registration number 09436004), authorised and regulated by the Financial Conduct Authority ("FCA") under firm reference number 705428 (hereinafter "Trading.com", "the Company", "we", "us" and "our"). The Company's registered office is at Coppergate House, 10 Whites Row, London, E1 7NF.

The "**Welcome Offer Program**" ("Welcome Offer") Terms and Conditions is an integral part of the "Client Agreement – Terms and Conditions of Business for Investment Account" and provisions set here are considered as an annex of all Trading.com Business Terms and Policies.

ELIGIBILITY CONDITIONS

1. This Welcome Offer is available to clients who meet the eligibility criteria described below. These terms apply alongside our standard Business Terms and Policies.
2. The Welcome Offer may be offered from time to time to clients who open a real investment account with us. Clients with CFD accounts only are not eligible for this promotion.
3. The Welcome Offer is available **only to new clients** and applies to their **first real investment account** with us.
4. Participation in the Welcome Offer is only allowed for individuals **over the age of 18**, who are **residents of the United Kingdom**.
5. If we detect that registration or trading details of one participant in the Welcome Offer match those of another participant (for example, the same IP address), we may disqualify the account(s) involved immediately.
6. Employees, partners, or anyone associated with the Company or its promotional activities cannot participate in this Welcome Offer.

SPECIFIC OFFER TERMS

1. Eligible Clients, who meet the criteria will receive Welcome Offer equal to:
 - 50 GBP (or equivalent)
2. To activate the Welcome Offer, you must **create and verify your investment account**.
3. If the client does not successfully deposit the minimum amount as required by the account or does not place at least one investment transaction **within ninety (90) days from the date of receiving the offer**, the Company will remove the Welcome Offer amount from the client's account without prior notice.
4. Clients can hold only one "Welcome Offer" Account per unique IP address. Multiple registrations from the same IP or multiple Accounts registered with the same personal details, are not allowed.
5. The Welcome Offer cannot be transferred between accounts, i.e. from investment account to CFD account.

6. Any profits generated using the Welcome Offer can be withdrawn following our standard withdrawal procedure.
7. This Welcome Offer will expire and be removed from your account, if **ALL** the following criteria are met:
 - a. No deposit(s) or internal transfer(s) have **ever** been made in your account;
 - b. **Either** no investment transaction has taken place within three (3) months from the date you registered your Investment Account, **or** where an investment transaction has occurred, three (3) months have elapsed from the date of the last transaction;
 - c. There are no open or pending orders on the account;
 - d. No other credits have ever been received in the account.
8. Should you request a transfer of your investment or portfolio deriving from your Welcome Offer, **All** the following criteria should be met:
 - a. Eligible Clients have deposited and placed a transaction with their investment account;
 - b. There is a minimum holding period of three (3) months for your investment or portfolio.
9. How our Deposit Offer will work when you open a trade:
 - a. Your own deposited funds are used first.
 - b. Any promotional credit is only used after your cash balance is fully used by you.
 This means you can only use the promotional credit after you have opened positions using your own deposited funds.
10. Similarly to the above, if there is a losing position, any losses will be deducted from your available balance first and any remaining losses, if any, from your credit.

GENERAL TERMS

1. The Welcome Offer may be used for investment purposes only and **cannot be withdrawn**.
2. We reserve the right to:
 - a. Decline registration in the Welcome Offer; and
 - b. Disqualify participants who tamper or attempt to tamper with the operation of the Welcome Offer or breach these terms and/or any of the Trading.com Terms and Conditions disclosed on the Company's website.

We are not responsible for any consequences of any offer cancellation, including any order(s) closure.
